- 1. Mayor Dillon called the meeting to Order at 7:00 p.m. and led the Pledge of Allegiance.
- 2. Roll Call: Members present were Mayor Dillon, Alderpersons Dohm, Thomas, Mathewson, Reagan, Abraham, and Ruskusky. Alderpersons Edmonds and Silver were absent. Also present were City Administrator Krider, City Treasurer McGill, City Attorney Connor, Street Department Manager Hess, Office Assistant Zych, County Clerk Rachel Parker, residents and guests Marlene Carter, Barry Cassano, Colin Corbett, Laurie & Matt Dillon, Bob DeSutter, Bonnie Farrell, Sharon Kennedy, Bret & Sam McGill, Clayton McNeil, Marina Nunez, Priscilla Peterson, Brandy Ruskusky, and Clerk Barnes.

- 6. Community Police Report was given by Deputy Tim Gilmore. He said that statistics would be sent to the City Administrator. Crime in West Peoria has calmed down but with warmer weather, crime always picks up. The bars in town have been quiet the last couple of weeks. The suspect of smashing windows fame has been apprehended, as well as the suspect of the armed robbery. He reminded citizens to lock their doors both home and autos by 9:00 p.m.
- 7. Mayor's Report included that he, City Administrator Krider, Street Department Manager Hess and the City Engineers have been reviewing sidewalks, crosswalks and other infrastructures to see what may need to be done in the near future.

He will also be having a meeting in the near future about the possibility of charging stations for electric vehicles in the City – how many, what types, and possible locations.

The Mayor thanked Alderperson Hazel Thomas and Alderperson Jeff Reagan for their many years of service to our City. Alderperson Thomas was a founding member of the City Council in 1993 and Alderperson Reagan has served the community for 12 years as Alderman. Congratulations to both of them with our thanks as well.

Presentation by City Administrator Krider included that the budget will need to be amended to add \$20,000.00 to line item 01-41-820 for a total of \$26,000.00 for a possible extension to a building at the City Garage. That request came after the FY 2024 Budget had passed through the Finance Committee and before this evening's meeting. That would put the City Under Budget by \$14,803.19 for FY 2024.
- d. Other Witness Testimony There were no other witnesses.
- e. A Motion to Finally Close the Public Hearing was made by Alderperson Mathewson at 7:16 p.m. and seconded by Alderperson Reagan. Discussion: There was no discussion. Sealcoating plans for the summer are underway. The Committee reviewed their goals for the next fiscal year. The Committee next meets on Wednesday, May 17, 2023 at 5:30 p.m. here at City Hall.
 - c. <u>Land Use Committee</u>: Chair Dohm: The Committee last met on **April 5, 2023**. The Committee next meets on Wednesday, **May 3, 2023** at 6:30 p.m. here at City Hall.
 - d. <u>Public Safety Committee</u>: Chair Reagan: The Committee last met on April 19, 2023. The Committee did its usual housekeeping duties, including the review of the Code Enforcement Report. The Committee had discussions about the Slow Down West Peoria program. Radar signs are up and running. A data report will be given next month. The Clean-up Day on April 29th is ready to proceed. Volunteers are still needed. If interested, please call City Hall. Lists of permitted and not permitted items are on the City's website.
 Commercial Container Enclosures all 42 of them were checked this week and only a couple of dumpsters/enclosures had any issues that were discussed with the owners. Priscilla Peterson gave a presentation of her research for a tree replacement program. Walk the Wards clean-up dates will be held the 3rd Saturday of each month beginning May 20th through September 9th. The group is hoping for a large group to help clean up our streets each month in designated areas. Please gather at 9:00 a.m. and get bags, gloves, and pick up sticks for use. Discussion: There is a need to amend this motion to include the changes outlined by City Administrator Krider in the Public Hearing into the Budget for FY 2024.

 A Motion to Amend the Annual Budget for FY 2024 according to the changes outlined by City Administrator Krider during the Public Hearing was made by Alderperson Reagan and seconded by Alderperson Mathewson. Returning to the Original Motion to pass Ordinance 2023 – 11 establishing the Annual Budget for the Fiscal Year 2024 as amended made by Alderperson Mathewson and seconded by Alderperson Ruskusky: Roll call votes: Ayes: Alderpersons: Mathewson, Ruskusky, Dohm, Thomas, Reagan, and Abraham – 6 Nays: - 0 Abstentions: - 0 Absent: Alderpersons Edmonds, Silver – 2 Motion carried.

- A Motion to pass Ordinance 2023 12 Approving and Adopting the Grant Programs for FY 2024 Residential Redevelopment Program, Residential Paint Program, Neighborhood Safety Improvement Grant Program, and Business Improvement Program was made by Alderperson Mathewson and seconded by Alderperson Abraham. Discussion: Alderperson Mathewson explained that this Ordinance sets the limits for grants given by the City. The only grant program with substantial changes was to the Business Improvement Program formerly known as the Business Façade Grant. Other changes include some small wording that will be highlighted on each application. No cash receipts will be acceptable beginning this year. Roll call votes: Ayes: Alderpersons: Mathewson, Abraham, Dohm, Thomas, Reagan, and Ruskusky 6 Nays: 0 Abstentions: 0 Absent: Alderpersons Edmonds, Silver 2
- c. A Motion to pass Ordinance 2023 13 Approving and Adopting FY 2024 Residential Redevelopment Program for West Peoria Tax Increment Financing (TIF) District 1 was made by Alderperson Mathewson and seconded by Alderperson Dohm. Discussion: Alderperson Mathewson stated that the City would hope that more residents residing in a TIF 1 area would use this funding more than has been used in the past. The length of time for TIF 1 is getting shorter. Some residents may not realize they live in that TIF district. Anyone with questions can call City Hall about their eligibility. Those residing in the area should receive a postcard informing them that they live in the district as well. Nebraska Ave., P.I.N. 18-06-102-002) was made by Alderperson Dohm and seconded by Alderperson Reagan. Discussion: This is a property that the building was torn down last year. The neighbor next door wants to expand a day care center. Roll call votes: Ayes: Alderpersons: Dohm, Reagan, Thomas, Mathewson, Abraham, and Ruskusky 6 Nays: 0 Abstentions: 0 Absent: Alderpersons Edmonds, Silver 2

- f. A Motion to pass Resolution 2023 05 Directing the Sale of a Portion of City-Owned Real Estate (823 N. Western Ave., P.I.N. 18-06-477-060) was made by Alderperson Reagan and seconded by Alderperson Dohm. Discussion: This is also a property where the building was torn down in hopes of making an area more business-friendly. It seems to be leaning that way. Roll call votes: Ayes: Alderpersons: Reagan, Dohm, Thomas, Mathewson, Abraham, and Ruskusky – 6 Nays: - 0 Abstentions: - 0 Absent: Alderpersons Edmonds, Silver – 2 Motion carried.
