- 1) Continue the new sidewalk program and persist with ongoing sidewalk repairs.
- 2) Pursue storm sewer improvement projects as needed throughout the City.
- 3) Pursue projects to continually improve roads and alleys throughout the City.
- 4) Work with the Finance Committee and investigate possibilities where TIF funds can be used to support public infrastructure projects.
- 5) Continue working on Illinois Environmental Protection Agency/National Pollution Discharge Elimination System & Storm Water Management Plan (IEPA – NPDES – SWMP).
- 6) Research other cities, similar in size and potentially develop alternative (outside-the-box) solutions to issues we are dealing with.
- 7) Continue to work with the Residents' Association and fellow Council members on City-wide initiatives specific to transportation.
- 8) Continue working with Public Safety to Slow Down West Peoria.
- 9) Develop and maintain a 5–10-year plan for Street Department types of equipment and vehicles.

1. Chair Silver called the meeting to order at 5:30 p.m.
2. Members present were Chair Silver and Alderperson Abraham. Alderperson Menke was absent. Also present were Administrator Krider, Street Department Manager Hess, Alderperson Dohm, residents Marlene Carter, Bonnie Farrell, Priscilla Peterson, and Clerk Barnes. Alderperson Mathewson and resident Susan Schlupp attended remotely.
3. There were no Additions to/or Deletions from the Agenda.
4. A Motion to approve the Minutes from the **May 17, 2023** regular meeting was made by Alderperson Abraham and seconded by Chair Silver. **Motion carried.**
5. A Motion to receive and file the Monthly Financial Reports from **April 2023** was made by Alderperson Abraham and seconded by Chair Silver. **Motion carried.**
6. Administrator's Report – Nothing at this time, but 9a. will have some updates.
7. Street Department Manager's Report
  - a. Idaho Sidewalk Project update – The project is ready, but Miller and Sons will begin after the 4<sup>th</sup> of July Parade.
  - b. Ardmore Place Sidewalk Project update – The project is complete and only the orange barrels have to be removed.
  - c. Vaughn/Magnolia Project update – There is no update as of now.
  - d. Other – Midwest Asphalt will begin spray patching next week, mostly from Farmington Road north, in preparation for seal coating that will begin in August. Trucks have all been inspected, and street cleaning for the 4<sup>th</sup> of July Parade will be done as close to the 4<sup>th</sup> as possible.
8. Public Comment: Is the parade route online? **Not yet, but it will be.** Will Swords Hill be closed? Maybe at the top, but the County was not contacted to close it from the bottom. Entrants will be asked to use the Heading to Alice to Rohmann route to line up for the parade.
9. Unfinished Business
  - a. Waverly/Callender Safety Study Grant – The application for this grant was submitted last Friday. If we are awarded that grant the Core Safety Study will be free to the City, and the Tri-County Regional Planning Commission (TCRPC) will oversee the project. We are only one applicant for a grant and asked for \$30,000.00, while there are 5 other municipalities applying as well. The Study would cover the safety of pedestrians, the Fire Department, and suggest ways to eliminate congestion in the area.
  - b. Rebuild IL Project update – The IDOT (Illinois Department of Transportation) paperwork has been submitted and returned to us as Approved. Now engineers and IDOT need to figure out how to proceed. All preparation work has been completed. It is hoped that the project will be completed before August.

c. Monthly Radar Review

Slow Down West Peoria – Radar Data this month was on Alice from Ashland to Swords, Alice from Swords to Ashland, and on Pierson from Farmington Road to Nebraska, and on Pierson from Nebraska to Farmington Road. While average speed hovers near the speed limit it was observed that there are about 10% of drivers that speed in those areas.

10. New Business

- d. A Motion to recommend to Council payment to **Horowitz Concrete** for work on Richmond Ave. in the amount of \$4,500.00 (line item: 01-41-890) was made by Alderperson Abraham and seconded by Chair Silver. **Motion carried.**


