Notice of Potential Majority of Quorum of the City Council and its Committees

In accordance with the provisions of 5 ILCS 120 (the Illinois Open Meetings Act), notice is hereby given that a majority of a quorum of the West Peoria City Council and its Committees may attend this meeting.

This event is designed to discuss City matters according to Committee descriptions.



- 1. Chair Silver called the meeting to order at 5:30 p.m.
- 2. Members present were Chair Silver and Alderperson Abraham. Also present were Administrator Krider, Street Department Manager Hess, Alderpersons Dohm, Mathewson, and Ruskusky, residents Marlene Carter, Mike Menke, Priscilla Peterson, and Clerk Barnes. Resident Susan Schlupp attended remotely.
- 3. There were no Additions to/or Deletions from the Agenda.
- 4. A Motion to approve the Minutes from the **April 19**, **2023** regular meeting was made by Alderperson Abraham and seconded by Chair Silver. **Motion carried.**
- 5. A Motion to receive and file the Monthly Financial Reports from **March 2023** was made by Alderperson Abraham and seconded by Chair Silver. **Motion carried.**
- 6. Administrator's Report She has been busy reviewing information about the Waverly/Callender intersection and found what might be a safety grant from the State. **This will be investigated.** Mayor Dillon joined the meeting at 5:35 p.m.
- 7. Street Department Manager's Report gave updates for the Idaho Sidewalk Project and Ardmore Place re-do from last year's project.
 Preparation work for the Rebuild IL funding project has begun: Moss is almost complete, Ayres has been started, and Sterling has been reviewed. All paperwork has to be completed and sent through Council to IDOT (Illinois Department of Transportation) before any actual work can be done.
- 8. Public Comment: Priscilla Peterson spoke to still gathering information about how to start a Tree Plan for the City with the idea of perhaps replacing some trees that have been destroyed by doing sidewalk projects around the City.
- 9. Unfinished Business
 - a. Idaho Sidewalk project update The project is still waiting on Comcast to move their lines. The project may be able to begin by the first of June or so.
 - b. Ardmore Place Sidewalk project update Manager Hess met with ICCI (Illinois Civil Contractors, Inc.) The start date is slated for Monday, May 21, 2023. All residents have been contacted. A bit over 50% of the project from last year has to be redone with asphalt, dirt work, and reseeding all being covered by ICCI.
 - c. Vaughn/Magnolia project update Letters have been sent out as of last Friday and only 2 responses have been returned. The last of May is the deadline to return the information requested.
 - d. A Motion to approve FY2024 Goals was made by Alderperson Abraham and seconded by Chair Silver. Included was a discussion about one goal that spoke to a problem on Richmond Avenue. Public Works is aware and has a plan.
 Motion carried.

FY 2024 Goals approved:

- 1) Continue the new sidewalk program and persist with ongoing sidewalk repairs.
- 2) Pursue storm sewer improvement projects as needed throughout the City.

- 3) Pursue projects to continually improve roads and alleys throughout the City.
- 4) Work with the Finance Committee and investigate possibilities where TIF funds can be used to support public infrastructure projects.
- 5) Continue working on Illinois Environmental Protection Agency/National Pollution Discharge Elimination System & Storm Water Management Plan (IEPA NPDES SWMP).
- 6) Research other cities, similar in size and potentially develop alternative (outside-the-box) solutions to issues we are dealing with.
- 7) Continue to work with the Residents' Association and fellow Council members on City-wide initiatives specific to transportation.
- 8) Continue working with Public Safety to Slow Down West Peoria.
- 9) Develop and maintain a 5-10 year plan for Street Department types of equipment and vehicles.

10. New Business

- a. Radar Data Review This month's report covered Waverly from Kellogg to Ayres, Waverly from Ayres to Kellogg; and Kenwood from Swords to Idaho and Kenwood from Idaho to Swords. There were 84 speeding tickets given for the month of April. Kenwood is the only street on this list where above-average speeds were recorded. All others in this set of data were below-average speeds with a few exceptions.
- b. A Motion to recommend to Council **Rebuild IL Project Resolution** was made by Alderperson Abraham and seconded by Chair Silver. The resolution is only the first of several steps and lots of paperwork will need to be done before this project can begin. The resolution had a change in the amount of money from \$375,000.00 to \$425,000.00. It is hoped that the City can keep moving forward quickly and finish the project in this construction season. **Motion carried.**
- 11. A Motion to recommend to Council payment to **Horowitz Concrete** for removal & replacement of ADA ramps at Moss, Bergan and Cedar in the amount of \$15,331.00 (line item: 15-00-860) was made by Alderperson Abraham and seconded by Chair Silver.

 Motion carried.
- 12. A Motion to recommend to Council payment to **Horowitz Concrete** for removal & replacement of two storm sewer inlets and curb line on Ayres in the amount of \$6,360.00 (line item: 01-41-890) was made by Alderperson Abraham and seconded by Chair Silver.

- 13. Public Comment: Alderperson Dohm suggested that the problem on Richmond be a curb instead of a swale in case further work would be done in the future.
 A question was asked about having an Ordinance against parking in front yards. There is such an Ordinance, it just needs to be enforced as possible.
- 14. A Motion to Adjourn was made by Alderperson Abraham at 6:14 p.m. and seconded by Chair Silver.

 Motion carried.
