City Council Meeting Minutes
West Peoria City Hall
Tuesday, June 13, 2023 at 7:00 p.m.

1. Mayor Dillon called the meeting to Order at 7:00 p.m. and led the Pledge of Allegiance.
2. Roll Call: Members present were Mayor Dillon, Alderpersons Dohm, Dillon, Mathewson, Abraham, Ruskusky, Menke, and Silver. Alderperson Corbett was absent. Also present were City Administrator Krider, City Treasurer McGill, residents Marlene Carter, Bob DeSutter, Bonnie Farrell, Sharon Kennedy, Emily Waite, guest Dave Schaab from Waste Management, and Clerk Barnes. City Attorney Connor, Alderperson Corbett, and residents Priscilla Peterson, Susan Schlupp and John Siewert II attended remotely.
3. Additions to/or Deletions from the Agenda
4. A Motion to Approve Minutes from the regular meeting of **May 23, 2023** was made by Alderperson Dohm and seconded by Alderperson Silver. Discussion: There was no discussion. Roll call votes: Ayes: Alderpersons: Dohm, Silver, Dillon, Mathewson, Abraham, Ruskusky and Menke – 7 Nays: - 0 Abstentions: - 0 Absent: Alderperson Corbett – 1 **Motion carried.**
5. A Motion to Approve Minutes from the special meeting of **June 7, 2023** was made by Alderperson Ruskusky and seconded by Alderperson Dillon. Discussion: There was no discussion. Roll call votes: Ayes: Alderpersons: Ruskusky, Dillon, Dohm, Mathewson, Abraham, Menke, and Silver – 7 Nays: - 0 Abstentions: - 0 Absent: Alderperson Corbett – 1 **Motion carried.**
6. Community Police Report was given by Deputy Tim Gilmore. The body of a missing person from out of town was found dead in one of the storage units. It was a case of mental health. He had no statistics for May but will get them to Administrator Krider. There seems to be a trend of dumping stolen cars in West Peoria, especially between 2-4 a.m. in the area of Ashland and Cortland. There has also been a caravan of stolen cars driven by juveniles during the early hours of the morning that's been captured on cameras. There have been a couple of cases of high-speed chases on 3rd shift and one on 2nd shift. Deputy Gilmore said he's not sure how many vehicles have been stolen since April, but it has increased, and there are reports of over 500 stolen vehicles in Peoria and the County this year, and the year isn't half over yet. Remember the old adage: "If you See Something, Say Something"? There was a case of a stolen 1959 Chevy that was captured on camera by several people who posted it on Facebook, but who never called the police about it. "If you See Something, Say Something"! If you see juveniles out late, call. They may not be up to no good, but they may be breaking curfew laws and that's when so much crime is committed. Someone asked about a Task Force that is supposed to be between Peoria, Peoria County, and the State police. When does that take effect? Not sure. It was supposed to start this spring, but it's been pushed back again. It's a Task Force to investigate stolen vehicles and vehicle parts like catalytic converters. Maybe by the end of the year, it will begin.
7. Mayor's Report included that he's been busy with several meetings with developers, the Liquor Commission, and even the 4th of July Parade which, so far, hasn't got as many entries as in past years. He, Administrator Krider, and several members of the Council attended the "Demolishment" announcement for Trillium (previously Heddington Oaks) as they begin the process of renovating the building for use by Carle for children and youth needing mental healthcare.
