- 1. Mayor Dillon called the meeting to Order at 7:00 p.m. and led the Pledge of Allegiance.

Also present were City Administrator Krider, City Treasurer McGill, residents Becky Burton, Marlene Carter, Bonnie Farrell, Laurie Hendrickson, Sharon Kennedy, Daryl Klusendorf, Priscilla Peterson, Emily Waite, Chuck Witkowski, guests Dan and Sara Schmalshof and Christine Patellaro, and Clerk Barnes. City Attorney Connor and residents Susan Schlupp and John Siewert II attended remotely.
- 3. There were no Additions to/or Deletions from the Agenda.
- 4. A Motion to Approve Minutes from the regular meeting of August 8, 2023 was made by Alderperson Silver and seconded by Alderperson Corbett. Discussion: There was no discussion. Roll call votes: Ayes: Alderpersons Silver, Corbett, Dohm, Dillon, Mathewson, Ruskusky, and Menke 7 Nays: 0 Abstentions: 0 Absent: Alderperson Abraham 1 Motion carried.
- A Motion to Receive and File the Treasurer's Report from June 2023 was made by Alderperson Mathewson and seconded by Alderperson Dillon. Discussion: There was no discussion. Roll call votes: Ayes: Alderpersons Mathewson, Dillon, Corbett, Dohm, Ruskusky, Menke, and Silver – 7 Nays: - 0 Abstentions: - 0 Absent: - Alderperson Abraham – 1

- 6. Community Police Report was given by Deputy Chief James Middlemas. School's back in session so Slow Down in the school zones and at crosswalks. The issue of buses that are speeding has been brought to the attention of the personnel at the Peoria District #150 Bus Barn. Vehicular break-ins and thefts continue on a regular basis.
 Deputy Gavin Watland has been named as a new 2nd shift Community Officer. Welcome to him! It was a unanimous decision about who to name. Deputy Watland is young and eager to help. He will be a good fit for this community.
- 7. Mayor's Report included that Deputy Watland came by last week and introduced himself to the Mayor and some staff members. There have been lots of meetings with business owners and the Business Owner's Association CORES. Thursday there will be a meeting with the architects for the new City Hall. There will be more information after that meeting.
- 8. Public Comment: Laurie Hendrickson thanked City Administrator Krider for meeting with her about the feral cat colony and what can be done about the problem. Mayor Dillon assured her that PCAPS (Peoria County Animal Protection Services) has recognized the new law and will be following the procedures set forth in Animal Control Act 102-0329. The City contracts with PCAPS for our needs.

 - a. <u>Finance Committee</u>: Chair Mathewson: The Committee last met on August 2, 2023.

 - b. <u>Transportation Committee</u>: Chair Silver: The Committee last met on **August 16, 2023**. The Committee did their usual housekeeping duties. The City has been awarded the \$30,000.00 grant for a Safety Study for the intersection of Waverly and Callender. Tri-County Regional Planning Commission will be the lead agency for the project and will report the

- results back to the City. Sidewalk project applications are being accepted until September 1st. One petition that is being circulated is for Laura Avenue. The Idaho sidewalk project is now set to begin the second week of September. Spray patching has been completed and sealcoating will begin later this fall. Rebuild IL project is still being worked on. The Committee next meets on Wednesday, **September 20, 2023** at 5:30 p.m. here at City Hall.
- c. <u>Land Use Committee</u>: Chair Dohm: The Committee last met on **August 2, 2023**. The Committee next meets on Wednesday, **September 6, 2023** at 6:30 p.m. here at City Hall.
- d. Public Safety Committee: Chair Ruskusky: The Committee last met on August 16, 2023 with all members present. The Committee did their usual housekeeping duties including a review of the Code Enforcement Report. The Committee reviewed the monthly radar report. The report this month gave data on Rohmann from Western to Sterling and Rohmann from Sterling to Western, and on Kenwood from Sterling to Avon and on Kenwood from Avon to Sterling. There are speeders, but the average speed remains at or below the posted limit. Concerning tree-replacement, Alderperson Abraham reported that 6 fruit trees have been planted at the Harold B. Dawson school and there are plans to place a dozen trees in the easement at St. Mary's Cemetery with the hopes of generational interest if planted by grandpas and grandchildren. Anyone wishing to sponsor a tree, contact Alderperson Abraham. Walk the Wards was last Saturday, August 19, 2023. Thanks to all who helped that day. The Committee sent to Council New Business c. for this evening's meeting. They reviewed the No Parking section of the Code Book concerning the layout of the information there for easier reading. The Committee next meets on Wednesday, September 20, 2023 at 6:30 p.m. here at City Hall.

Discussion: An explanation of what the mitigation plan is about was given by Administrator Krider. She also explained that the Public Safety Committee will be working on the plan and how it applies to our City. There will be a report to make about their work and ours as a city every five years similar to the yearly report for IEPA (Illinois Environmental Protection Agency) done by the Transportation Committee.

Discussion: For the newer members of the Council it was mentioned that belonging to the Tri-County Regional Planning Commission is important as federal funding comes through that group. The City just received a grant for a safety study for the congested intersection at Callender and Waverly through them and they get our City maps printed for us. City Administrator Krider is the Chairwoman for the Technical Committee for the group.
