FY2024 Goals

- 1) Continue the new sidewalk program and persist with ongoing sidewalk repairs.
- 2) Pursue storm sewer improvement projects as needed throughout the City.
- 3) Pursue projects to continually improve roads and alleys throughout the City.
- 4) Work with the Finance Committee and investigate possibilities where TIF funds can be used to support public infrastructure projects.
- 5) Continue working on Illinois Environmental Protection Agency/National Pollution Discharge Elimination System & Storm Water Management Plan (IEPA NPDES SWMP).
- 6) Research other cities, similar in size and potentially develop alternative (outside-the-box) solutions to issues we are dealing with.
- 7) Continue to work with the Residents' Association and fellow Council members on City-wide initiatives specific to transportation.
- 8) Continue working with Public Safety to Slow Down West Peoria.
- 9) Develop and maintain a 5-10 year plan for Street Department types of equipment and vehicles.

- 1. Chair Silver called the meeting to order at 5:30 p.m. and welcomed Alderperson Menke to the Committee.
- 2. Members present were Chair Silver, Alderpersons Abraham and Menke. Also present were Administrator Krider, Alderperson Dohm, Street Department Manager Hess, residents Becky Burton, Marlene Carter, Priscilla Peterson, Roland Reinhart, and Clerk Barnes. Alderperson Mathewson, and residents Susan Schlupp, and John Siewert II attended remotely.
- 3. There were no Additions to/or Deletions from the Agenda.
- 4. A Motion to approve the Minutes from the **July 19, 2023** regular meeting was made by Alderperson Abraham and seconded by Chair Silver. **Motion carried.**
- A Motion to receive and file the Monthly Financial Reports from June 2023 was made by Alderperson Menke and seconded by Alderperson Abraham.
 Motion carried.
- 6. Administrator's Report
 - a. Waverly/Callender Safety Study Grant update: The City has been awarded the \$30,000.00 grant for the Safety Study. Tri-County Regional Planning Commission will be the lead agency for the project and will be finding an engineering firm to do the work. There are a lot of moving parts to the studies and 4-5 other municipalities have also been awarded grants. Right now, Tri-County has put out RFP Requests for proposals from engineering firms. The City will get updates from them, and Administrator Krider will pass them on to this Committee.
 - b. A map for Laura Avenue was handed out. This may be a possible project for next year. There is a volunteer going from door to door to get signatures for the project. If no one is found to be home, a letter will be sent to the homeowners, landlords, and renters. It was pointed out that Downs Circle would be ideal to help finish up the area and wrap around on Sterling as well.
- 7. Street Department Manager's Report
 - a. Idaho Sidewalk Project update is now set to begin the second week of September. They have until November 1, 2023 to get it done, but that time gets close to the asphalt company closing for the year.
 - b. Spray patching / Sealcoating update: Spray patching is almost complete. Sealcoating usually takes place in later fall to allow materials to cure.
 - c. Other: Seeding is taking hold on Ardmore. On Richmond/Pierson drainage is working no more water from the street into the yard.
- 8. There was no Public Comment at this time.

9. Unfinished Business

- a. Rebuild IL Project update Headway is being made. Engineers have all paperwork to IDOT (Illinois Department of Transportation) Ayres at Western may be too expensive to complete at this time, so that may be dropped from the project, depending on a request to only do part of it.
- b. Monthly Radar review The report this month gave data on Rohmann from Western to Sterling and Rohmann from Sterling to Western, and on Kenwood from Sterling to Avon and on Kenwood from Avon to Sterling. There are still speeders, but the average speed is at or below the posted limit.
- c. Vaughn / Magnolia update still discussing what to do.
