City Council Meeting Official Minutes West Peoria City Hall Tuesday, May 10, 2022 at 7:00 p.m.

- 1. Mayor Dillon called the meeting to order at 7:00 p.m. and led the Pledge of Allegiance.
- Roll Call: Members present were Mayor Dillon, Alderpersons Dohm, Thomas, Mathewson, Abraham, Edmonds, and Silver. Alderperson Reagan was absent. Alderperson Ruskusky, Attorney Connor, Attorney Clay Curcio, and resident Priscilla Peterson attended remotely. Also present were City Administrator Krider, City Treasurer McGill, residents Marlene Carter, Robert DeSutter and Bonnie Farrell, and Deputy Clerk Zych.
- 3. There were No Additions to/or Deletions from the Agenda.
- A Motion to Approve the Minutes from the regular meeting of April 26, 2022 was made by Alderperson Thomas and seconded by Alderperson Edmonds. Discussion: No Corrections. Roll call votes: Ayes: Alderpersons: Thomas, Edmonds, Dohm, Mathewson, Abraham, Ruskusky, and Silver – 7; Nays: 0; Abstentions: 0; Absent: Reagan – 1.
- 5. Community Police Report No deputy was available to report at this time.
- 6. Mayor's Report
 - He and other representatives of West Peoria attended an Open House at the Hindu Temple. They explained the history of the temple and provided traditional food.
