Also present were Mayor Dillon, Administrator Krider, Street Department Manager Hess, Alderpersons Dohm and Ruskusky, residents Marlene Carter, Bonnie Farrell, and Clerk Barnes. Alderperson Mathewson and residents Priscilla Peterson and Susan Schlupp attended remotely.
- 3. There were no Additions to/or Deletions from the Agenda.
- 4. A Motion to approve the Minutes from the October 18, 2023 regular meeting was made by Alderperson Abraham and seconded by Alderperson Menke.

- 5. A Motion to receive and file the Monthly Financial Reports from **September 2023** was made by Alderperson Abraham and seconded by Alderperson Menke. **Motion carried.**
- 6. Administrator's Report included a reminder about the grant from the Tri-County Regional Planning Commission that we received for a corridor study of the Waverly/Calendar/Ayres area. They are presently looking for RFQs (Requests For Quotes) and expect that the study may begin in February or March. It may take a year to complete.
- 7. Street Department Manager's Report: Boyer Concrete Leveling has been hired to do some preventative maintenance by leveling the sidewalks on Heading Avenue from Sterling Avenue to Waverly Avenue. Some of the sidewalks are 1-2" tripping hazards. This work will begin soon. Others are too broken up to merely level, and they will be repaired in the spring.
- 8. There was no Public Comment at this time.
- 9. Unfinished Business:
  - a. Rebuild IL Project update: The paving of Moss, Ayres, and Sterling Avenues has been completed. The 22 manhole covers and the water lids will be lifted up to match the street and reset starting probably the Monday after Thanksgiving.
  - b. Monthly Radar Review: This month's radar centered on Heading Avenue from Sterling Avenue to Western Avenue and Heading from Western Avenue to Sterling Avenue; and Rohmann Avenue from Swords Avenue to Sterling Avenue, and Rohmann Avenue from Sterling Avenue to Swords Avenue. There seems to be a slight lessening of speeders on Heading probably in response to the many tickets issued. Rohmann continues to have the highest number of vehicles and speeders. This is the final data for this fall. Next month there will be the Annual Summary Report.
  - c. Vaughn / Magnolia update: The Street Department will go to the site in the spring to use the chipper and remove some brush. A couple of residents whose homes are in the area and who have not yet responded to the letter sent out in May will be contacted.

d. Laura Avenue and Downs Circle Sidewalk Projects: Were reviewed. Next month the Alderpersons will need to decide which of the projects (or both) can be completed with available funding. The Committee members were asked to walk the streets and see which is more necessary at this time if both projects cannot be completed.
