Notice of Potential Majority of Quorum of the City Council

In accordance with the provisions of 5 ILCS 120 (The Illinois Open Meetings Act), notice is hereby given that a majority of a quorum of the West Peoria City Council and its committees, may be in attendance at this meeting. This event is designed to discuss City matters according to Committee descriptions.



1. Chair Silver called the meeting to order at 5:30 p.m.
2. Members present were Chair Silver and Alderperson Thomas. Alderperson Edmonds attended remotely as did Alderperson Mathewson, and resident Priscilla Peterson. Also present were City Administrator Krider, Public Works Manager Hess, Alderpersons Dohm and Abraham, resident Nick Baker, and Clerk Barnes.
3. There were no Additions to/or Deletions from the Agenda.
4. A Motion to approve the Minutes of the January 19, 2022 regular meeting was made by Alderperson Thomas and seconded by Alderperson Edmonds. **Motion carried.**
5. A Motion to receive and file the Monthly Financial Report from December 2021 was made by Alderperson Edmonds and seconded by Alderperson Thomas. **Motion carried.**
6. Administrator's Report included that she has been working on the FY2023 Budget and looking for Grants for various City projects. Rebuild Illinois has to have bondable projects like infrastructure or planning. Perhaps projects like milling and overlay of two inches on some streets like Alice and Idaho could benefit from those funds. Tri-County Regional Planning Commission is going to run some numbers for the City to see if that will be beneficial.
Question: Could those funds be used in a TIF District? It is preferred to use TIF funds for TIF areas, and use Rebuild Illinois for other areas. What about using Rebuild Illinois funds for GIS storm sewer mapping that needs to get done? Those funds are not available for use with the mapping.
7. Public Works Manager's Report included that the snowplows and large truck are ready for the next snowfall. Comments were made as to the great job the street department crew did during the last snowfall.
8. No Public Comment was offered.
9. Unfinished Business
 - a. Slow Down West Peoria – Administrator Krider **will be researching the costs of a speed study for our streets to determine the feasibility.** There is a need to balance parking practices in the street and pedestrian activities besides pace, road characteristics, shoulder condition, grade, alignment, and sight distance. She will be reaching out to Tri-County Regional Planning Commission and our current engineers for their help.
 - b. Radar Data Discussion will continue next month when more data is available.
 - c. FY2023 Budget discussion concluded with a Motion to send the Transportation FY 2023 Budget to the Finance Committee moved by Chair Silver and seconded by Alderperson Thomas. **Motion carried.**
 - d. FY2023 Goals Review – concluded with **adding the following Goals** to the current 2023 Goals:

Rebuild Illinois project study to see where the funds can best be used.
Complete GIS (Geographic Information System) storm sewer mapping.
Compile a Street Department "Wish List."
Public Works Manger Hess to complete a 5-10 year plan for the Street Department.

It was requested that the **Goals be added to the agenda** for the Transportation Committee so that they could be checked occasionally.

10. New Business

- a. "Non-compliant business" in a residential area. Section 2-12-2 Definitions, Home Occupation, and Section 2-5-1 Medium Density Residential District.

This was added to the agenda to make the Committee aware of the situation. There has not been a violation seen since the owner was made aware of the concerns. This should be **sent on to the Land Use Committee, and the parking section to the Public Safety Committee.**


11. Public Comment: Someone commented that there are other situations of home occupations that need investigating.
