- 1. Chair Ruskusky called the meeting to order at 6:31 p.m.
- 2. Members present were Chair Ruskusky and Alderperson Abraham. Alderperson Menke was absent. Also present were City Administrator Krider, Alderperson Dohm, residents Marlene Carter, Bonnie Farrell, Kim Hanks, Priscilla Peterson, and Clerk Barnes. Residents Susan Schlupp and John Siewert II attended remotely.
- 3. There were no Additions to/or Deletions from the Agenda.
- 5. A Motion to receive and file the Monthly Financial Report from **May 2023** was made by Alderperson and seconded by Chair Ruskusky. **Motion carried.**
- 6. City Administrator's Report There is nothing at this time.
- 7. Public Comment It was suggested that perhaps to help with crime efforts in our community we should get to know our neighbors better by learning who lives on either side of us, across the street and on either side of them. We could know them, the vehicles attached to that address, and watch to see if there is anything unusual, even calling the police if necessary. We don't want to be "nosy" neighbors but want to help protect each other and their property.

8. Code Enforcement Report:

- a. Permit List was reviewed.

- c. Foreclosure/Vacant Structures List There is no report at this time.
- d. Nuisance Properties There is no list at this time.
- e. Case Detail List was reviewed. There are only 33 open cases at this time.
- f. Case Summary List was reviewed. Year-to-date through June 29, 2023 there have been 641 violations: 161 weeds/debris premises free and clean; 156 of grass height, 105 wrong-way parking, and 27 parking on unpaved surfaces were the among the highest numbers of violations.

9. Unfinished Business:

- a. Slow Down West Peoria The Monthly Radar Review was discussed. This Month's report included Sterling Avenue from Heading Avenue to Rohmann Avenue, and Sterling Avenue from Rohmann Avenue to Heading Avenue.
 - Also in this month was a report for Rohmann Avenue from Sterling Avenue to Swords Avenue and Rohmann Avenue from Swords Avenue to Sterling Avenue.
 - It was observed that there were several speeders, but the daily average was still under the posted limit. These reviews will be given to the community officers.
- b. Walk the Wards update: It was last held Saturday July 15th. There was one additional helper this month. Please come and help us clean up the "hot spots" of trash. Neighbors cheered on the volunteers and appreciate what they were doing.

The next Walk the Wards is scheduled for August 19, 2023 at 9:00 a.m. at City Hall.

- d. ProChamps/Hera Property Registry The agreement with Hera has been signed and we are waiting until the information is transitioned. One resident asked for an explanation of what this was all about and was informed by Administrator Krider.
