- Mayor Dillon called the meeting to order at 7:00 p.m. and led the Pledge of Allegiance. A moment of silence was observed in memory of Jerry Meismer who died last week. He was an Alderman, Chairman of the Finance Committee for many years, and a member of the Planning Commission and Zoning Board of Appeals most recently.
- 2. Roll Call: Members present were Mayor Dillon, Alderpersons Dohm, Thomas, Mathewson, Reagan, Abraham, Edmonds, and Silver. Alderperson Ruskusky attended remotely as did City Attorney Connor and resident Priscilla Peterson. Also present were City Administrator Krider, City Treasurer McGill, resident Sharon Kennedy, and Clerk Barnes.
- 3. There were No Additions to/or Deletions from the Agenda.
- A Motion to Approve the Minutes from the regular meeting of September 13, 2022 was made by Alderperson Thomas and seconded by Alderperson Reagan. Discussion: No discussion. Roll call votes: Ayes: Alderpersons: Thomas, Reagan, Dohm, Mathewson, Abraham, Ruskusky, Edmonds, and Silver 8 Nays: 0 Abstentions: 0 Absent: 0 Motion carried.
- A Motion to Receive and File the Treasurer's Report from July 2022 was made by Alderperson Mathewson and seconded by Alderperson Abraham. Discussion: No discussion. Roll call votes: Ayes: Alderpersons: Mathewson, Abraham, Dohm, Thomas, Reagan, Ruskusky, Edmonds, and Silver – 8 Nays: - 0 Abstentions: - 0 Absent: - 0
- 6. Community Police Report: Mayor Dillon stated that the City has received a copy of the proposed 5year contract from the Peoria County Sheriff's Office. The contract is up for renewal January 1, 2023. There is a considerable raise of fees. He and Administrator Krider will be meeting with the Sheriff's Office to discuss the contract soon.

There were 8 shots fired on Farmington Road near the car wash. Only thing that was hit was a car that had three holes in it.

- Mayor's Report included that Swords Hill construction is coming along well. Temporary licenses have been received for the new trucks, and they are being readied for use. Sidewalks are completed on Laura, and about half done on Cortland. Sealcoating is finished and fog seal will be finished this week.

- 9. Committee Reports:
 - a. <u>Finance Committee</u>: Chair Mathewson: The Committee last met September 7, 2022. The Committee next meets on Wednesday, October 5, 2022 at 5:30 p.m. here at City Hall.
 - b. <u>Transportation Committee</u>: Chair Silver: The Committee last met September 21, 2022. The Committee did its usual housekeeping duties. Street Manager Hess reported that the Sidewalk project on Laura is complete and half of the project on Cortland is also complete. Sealcoating is complete and spray patching should be complete very soon. The Department has received the F250 truck and the F550 should be in service by the end of next week. Radar data was reviewed. This month was Waverly to Sterling, both directions, on Callendar and Ayres

Avenues. Average speed was still about 20 mph, but there were plenty of speeders. The speeders 10-15 mph over the limit were, surprisingly, during mid-afternoon and early evening. Street Manager Hess commented he would like to see radar results for Waverly. Bike racks were discussed, with one that will be placed at City Hall and Peoria Park District will be contacted to see if they will put one at Franciscan Recreation Center. Other ideas for placement are welcome. Several items were recommended to the Council for this evening's meeting. One sidewalk petition for SSA 2023 was reviewed. Administrator Krider is still awaiting the estimate for the Vaughn/Magnolia project from Terra Engineers. Ardmore sidewalk project is being sent to Attorney Connor since there still has been no response from the contractors of that project. The Committee next meets on Wednesday, October 19, 2022 at 5:30 p.m. here at City Hall.

The monthly radar data was reviewed. A Code Book Amendment for Section 4-4 on the Regulation of Dogs, Cats and Other Animals was reviewed, and the Committee recommended that the final draft be sent to Council. A fireworks ordinance will be put in a final version for next month's meeting. The Committee received an update about the Nebraska property.
