Notice of Potential Majority of Quorum of the City Council and its Committees

In accordance with the provisions of 5 ILCS 120 (the Illinois Open Meetings Act), notice is hereby given that a majority of a quorum of the West Peoria City Council and its Committees may attend this meeting.

This event is designed to discuss City matters according to Committee descriptions.



- 1. Chair Dohm called the meeting to order at 6:37 p.m.
- 2. Members present were Chair Dohm, Alderpersons Corbett and Dillon. Also present were Administrator Krider, Alderperson Menke, residents Marlene Carter and John Siewert II, and Clerk Barnes. Alderperson Silver and residents Priscilla Peterson and Susan Schlupp attended remotely.
- 3. There were no Additions to/or Deletions from the Agenda.
- 4. A Motion to approve the Minutes from the **December 6, 2023** regular meeting was made by Alderperson Dillon and seconded by Alderperson Corbett.

 Motion carried.
- A Motion to receive and file Monthly Financial Report from November 2023 was made by Alderperson Corbett and seconded by Alderperson Dillon.
 Motion carried.
- 6. The City Administrator's Report included working on the first draft of the FY2025 Budget, and working on the Enterprise Zone Amendment, to be covered under 10b of the Agenda. Included in the packets for this meeting was the Rental Registration Report. There are 535 non-owner-occupied properties. 214 postcards were mailed out to West Peoria presumed landlords based on the Peoria County GIS (Geographic Information System) report. 89 emails were sent to previous landlords from our current database. The City posted a Rental Registration notice on the website, the Facebook West Peoria Community page, and the Simplicity App with a link to our Rental Registration form for ease of updating information. Responses have been: 80 landlords at the end of November, with 276 addresses currently confirmed which is over 51% responsiveness. 12 postcards were returned as undeliverable.
- 7. Public Comment: Question Are Air B&Bs included in those Rental Registrations? No. Shouldn't they be paying us taxes? **This will be checked into.**
- 8. Code Enforcement Report:
 - a. Permit List was reviewed. There were 129 permits issued this past year.
 - b. Work Order List was reviewed. Fines need to be paid by the 19th or filing a lien against the properties will be done.
 - c. Foreclosure/Vacant Structures List was reviewed. It was decided to continue presenting the information the way it is currently being done.
 - d. Case Detail Report was reviewed.
 - e. Case Summary List was reviewed. There were 1,343 year-to-date violations, (through December 22, 2023). Of those violations, 388 were for Weeds/Grass Height; 353 for Weeds/ Debris; 207 for Wrong-way parking; 51 for Toters for Curbside Collection; 50 for Parking on Unpaved surfaces; 49 for Inoperable Vehicles; and 42 for Snow Ban violations.

9. Unfinished Business:

a. City Hall updates – decisions are being made about façades, some colors, placement of windows, etc. 80% of materials will need to be decided upon by January 18 to begin the process for bidding. Depending on numbers, some decisions may have to be altered.

- b. Review of Code Section 5-3 Adult Businesses This will be dropped from the agenda for the time being and brought back as needed.
- c. Enterprise Zone Currently the properties in the Enterprise Zone are being surveyed.

A question concerning the burnt adult-use building on Farmington Road was discussed. There needs to be a deadline for a decision regarding what will happen to it.
- c. A Motion to recommend to Planning Commission and ZBA EV-Capable Parking Space Requirements was made by Alderperson Corbett and seconded by Alderperson Dillon. Motion carried.
